It maintains a database which traces the genealogy and pedigree of New Zealand Dogs as well as progression of sports associated with Canines. (Breed Clubs, Obedience, Agility, Working Trials, (Eukanuba) Canine Good Citizen™, New Zealand Young Kennel Club and others).

Department Functions

The core areas of the administrations of business include:

- **Canine Registry & Member Support Services**
 - This function is represented by a team of “Member Support Officers” who deal with a host of items from Dog Registrations, Litter Notifications, Transfer of Ownership to Issue of Show Licences and down to administration of Judges.
 - Show Calendar management and co-ordination with clubs
- **Financial Management & Compliance**
 - Critical to any business is good financial management, this department looks after all aspects of the clubs financial management and statutory compliance
- **Facilities & Infrastructure Management**
 - The club owns a number of properties throughout New Zealand. To this end the club needs to manage its property portfolio (all aspects including venue hire, maintenance and resource compliance).
 - The club relies heavily on modern Information Technology Resource and this requires forward planning, maintenance and on going design and development
- **Publishing & Web Design**
 - The club publishes a monthly publication, including a Gazette detailing meetings of the Executive Council, upcoming events and shows along with other topical items in the Dog World
 - The club also has web based facilities for customers and members, this requires on going development and maintenance.
